Pursuant to the Freedom of Information Act (FOIA)<sup>1</sup> and the Federal Energy Regulatory Commission's (Commission) regulations, 18 C.F.R. § 388.112(d) (2021), you are hereby notified that an individual has filed a request for material that the North American Electric Reliability Corporation (NERC) has submitted as privileged or confidential in connection with, among other dockets, RC13-2.

Because NERC has asserted a privileged and/or confidential interest in the information requested, we are soliciting your comments on whether release of the information is required under the FOIA. In those instances in which we have relevant contact information for the concerned UREs, we are also providing a copy of this notice to those entities.<sup>2</sup> However, we also ask that you advise the relevant URE(s) of this notice to ensure receipt. Your comments are due within five (5) business days from the date of this letter, and should clearly explain whether you oppose the release of this information and the rationale for your position. The Commission will not be persuaded by conclusory statements or assertions as to why the identity of a URE deserves protection. The Commission may construe a non-response as evidence that you do not object to releasing the name.
