

Instructions for filing an intervention to FERC:

Background:

- The Secure the Grid Coalition filed a Complaint on March 9th with FERC that argued: 1. The current NERC standard for GIC protection is inadequate (NERC TPL-007-4) and, 2. The electric utility industry must be incentivized by cost recovery to protect the grid from GIC to the Department of Energy recommendations,3 Congressional EMP Commission recommendations4, and the International Electrotechnical Commission (IEC) Standard5 and to avoid exceeding the IEEE 519 Standard6 due to GIC induced harmonics which is costing the U.S. economy billions of dollars each year.
- FERC opened a docket on this issue, which is **Docket No. EL26-49**
- When someone intervenes on this docket, it tells FERC that there are interested parties and allows for those parties to comment on the matter. Thus we would really appreciate as many STG Coalition members possible file interventions.
- **The deadline to file an intervention and/or Comment on this docket is 5:00 Eastern Time on March 30, 2026**
